RESOLUTION TO ENTER INTO A PROFESSIONAL SERVICES CONTRACT FOR HOUSING COORDINATION SERVICES WITH RUPCO INC.

Weyer reviewed the Status report and updated the Board on work done since the last meeting. A correspondence was received from the Village of Monticello requesting a Business Plan for the Land Bank. While not a typical request, a plan will be developed and submitted to the Village for review.

The Realtor Forums were a success but more outreach is needed to get involvement and support. Additional outreach is needed for transferring properties and two realtor events will be planned for November to get more input and buy-in from the Realtor community.

Jill presented to a decent crowd at Sullivan Renaissance's December Planning Seminar and gave an update on the Land Bank.
